DEA Launches New Educational Website for Parents: www.GetSmartAboutDrugs.com

GetSmartAboutDrugs.com was developed as a resource for parents and caregivers to help them identify drug abuse, prevent children from using drugs, and find resources for substance abuse prevention in an informative, non-technical manner.

The website was introduced February 11 at the annual National Leadership Forum of one of DEA's partner organizations, the Community Anti-Drugs Coalition of America. Speaking to forum participants, Acting Administrator Michele M. Leonhart said, "In this fight, information is power, and DEA's new website has current, accurate, and practical information about how to spot signs of abuse, identify drugs and paraphernalia, and how to talk to teens about drugs."

For many, St. Patrick's Day is a popular day of celebration. From parades to parties, Hoosiers across the state will participate in events that celebrate Irish heritage. Yet given that many of these festivities will include alcohol, this time of year can also be very dangerous.

In an effort to deter impaired and dangerous driving on Indiana's roadways this month, the Indiana Criminal Justice Institute is joining with over 250 state and local law enforcement agencies to launch Operation Pull Over blitz 58.

During this statewide, high-visibility enforcement (March 6-22), participating law enforcement agencies will deploy sobriety checkpoints, saturation patrols, and other enforcement activities designed to detect (and arrest) impaired drivers. Officers will also be on the lookout for aggressive and unbelted motorists.

"March is a spirited time for Hoosiers – from Big Ten basketball to St. Patrick's Day celebrations, the month will see numerous opportunities for us to celebrate with family and friends," said Indiana Criminal Justice Institute (ICJI) Executive Director Neil Moore. "If you plan to drink during these festivities, don't rely on luck to keep you safe or to keep you out of trouble. Be responsible and take appropriate precautions."

Over the past five years, a total of nine people lost their lives in motor vehicles crashes during the St. Patrick's Day holiday (March 17th) statewide. Of that number, 33 percent were killed in an alcohol-related crash. The proportion of traffic fatalities accounted for by drivers involved in alcohol-related crashes has increased annually at a rate of 5.5 percent statewide.

Every Hoosier can enjoy a safe St. Patrick's Day by remembering a few easy tips:

- Plan ahead. Designate a sober driver and give that person your keys.
- If you become impaired, use a taxi, or ask a sober friend or family member to drive.
- If you happen to see a drunk driver on the road, call 911.
- If you think someone is about to drive or ride impaired, take their keys! Drive them yourself or help them make other arrangements.

R J Reynolds Introducing Dissolvable Tobacco in Portland, in January 2009

R.J. Reynolds Tobacco Co. is introducing three dissolvable tobacco products in its latest bid to make its tobacco more accessible within a society that's clamping down on smoking.



- The dissolvable tobacco products include...
 - a pellet (Camel Orbs)
 - a twisted stick the size of a toothpick (Camel Sticks)
 - a film strip for the tongue (Camel Strips)
- Reynolds plans to test the new orbs and sticks products in Portland in January
- and the strips in the second quarter

A statement from The Campaign for Tobacco-Free Kids protests this new development: "These products are flavored and packaged like candy, and very likely will appeal to children," said Matthew Myers, the president of the advocacy group.
